Attached please find two (2) outstanding bills due to the Rhode Island Interscholastic League (RIIL):

1. East Providence High School Sports Dues and Fees in the amount of \$5,096.00.
2. East Providence High School Hockey Assessment in the amount of \$1,300.00 which is used to pay only the referees for East Providence High School's eighteen (18) game schedule. All other expenses for running hockey are borne by the RIIL.

The RIIL Rules and Regulations state:
